### **Course Description:**

To prepare the student to work with a balanced approach, using both technical and artistic abilities, to collaborate effectively within a theatrical production process.

Note: Normally restricted to BFA Technical Theatre: Technical Production students. Prerequisite: DRAMA 292 and/or consent of the Department.

## **Course Objectives and Expected Learning Outcomes:**

Students will cover several topics which will form their foundation to operate as audio technicians and sound designers in a professional theatre setting. Subjects such as; the science of sound, live audio engineering and sound system design are presented for specialized theatrical applications.
